## **General Release of Liability**

The administration, faculty, and employees, and others involved in the administration of the various programs of Dayton Public Schools (the "District") are committed to using all reasonable precautions to minimize or eliminate the potential for injury of children, including students of the District and children that attend other schools to whom the District provides transportation, while they are participating in school sponsored activities or traveling to and from their schools on District provided transportation. The District is also committed to putting in place preventative measures to reduce the spread of infectious diseases, including COVID-19.

As the lawful parent or guardian of the child named below, I acknowledge that the District cannot guarantee that a child participating in school sponsored activities or traveling to and from his or her school will not become infected with COVID-19 or other infectious diseases. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I or my child may be exposed to or infected by COVID-19 through participating in school sponsored activities or in connection to my child traveling to and from his or her school on District provided transportation and that such exposure or infection may result in personal injury, illness, permanent disability, or death.

In addition, I release and hold harmless the District and its administration, faculty, agents, representatives, volunteers, and employees from any and all liability, actions, causes of action, claims, judgments, costs, and expenses, including attorneys' fees, arising out of any injury, illness (including COVID-19), or damage to personal property incurred by my child while attending the District or related to my child traveling to and from his or her school on District provided transportation and further agree not to bring or prosecute or allow to be brought or prosecuted (including but not limited to prosecution through subrogation) in my name, or on behalf of my child, any claims, lawsuits or actions against the District or its administration, faculty, agents, representatives, volunteers, and employees.

This acknowledgement and release is intended to be as broad and inclusive as permitted by the law of the State of Ohio, and if any portion hereof is declared invalid, it is agreed that the balance, notwithstanding, continues in full legal force and effect. I have carefully read, understand, and accept the terms and conditions stated above and acknowledge this Permission shall be effective and binding upon me, my child, and my own and my child's personal representative or estate, assigns, heirs, and next of kin, and that I have signed this agreement of my own free will.
